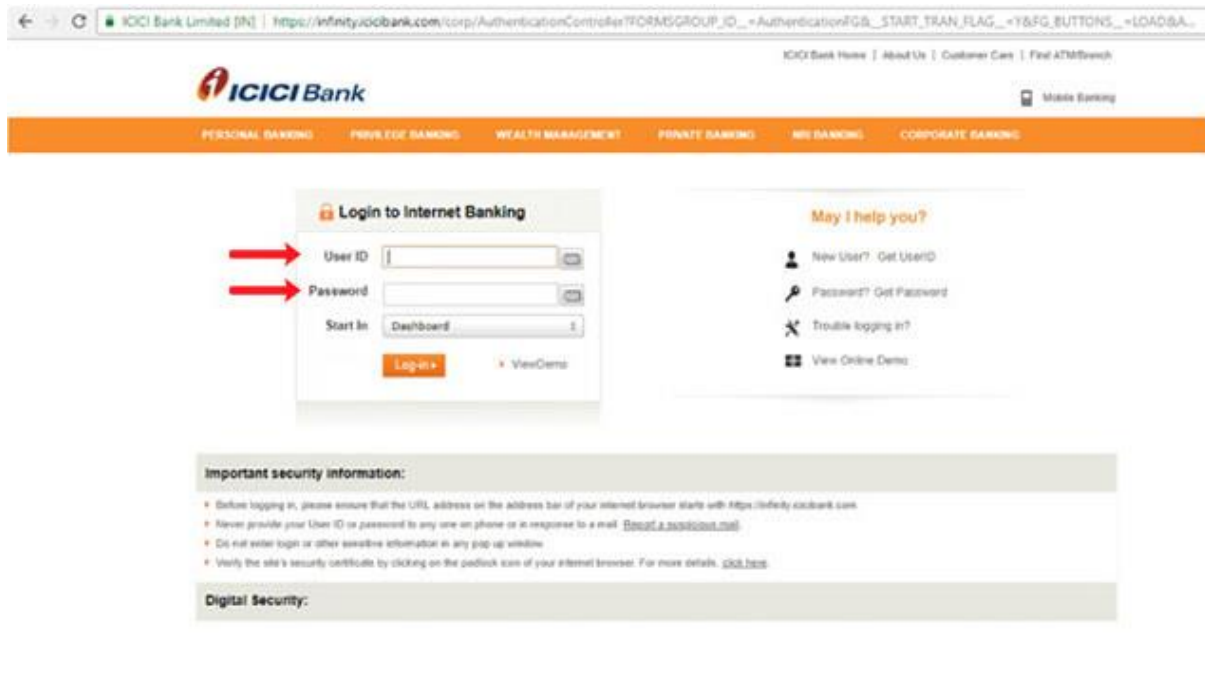
Step 2:Select the option to e-verify via generating Electronic Verification Code (EVC)-Through Net Banking



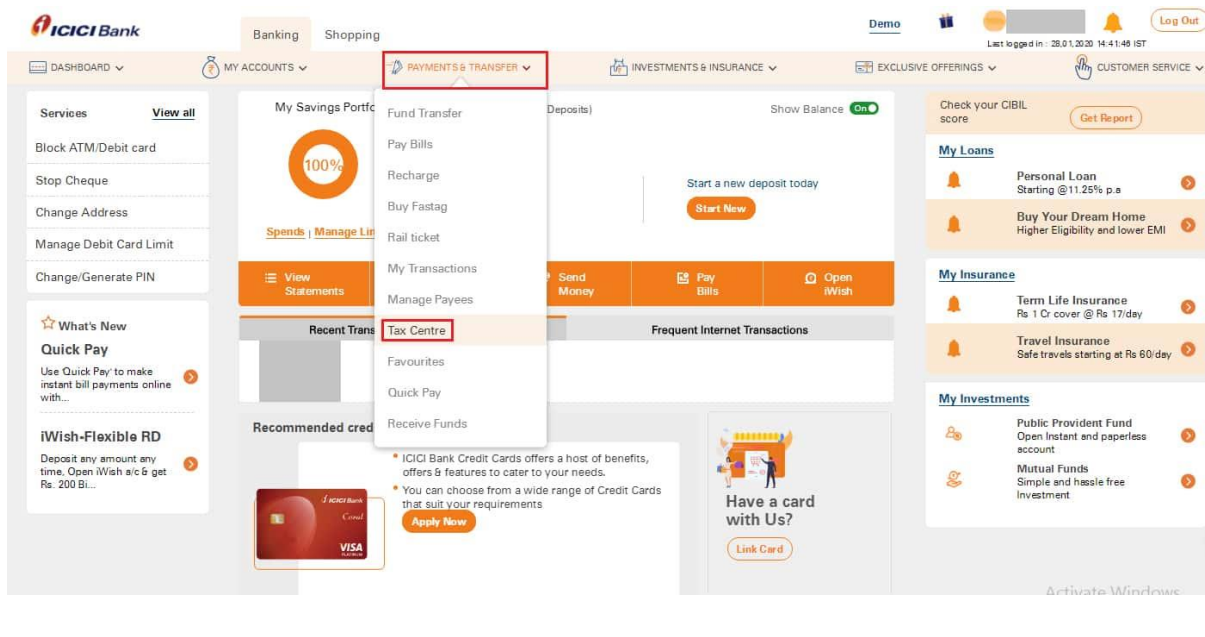
Step 3: Step 3:- Once selecting the net banking option, you will be asked to select your preferred net banking, select ICICI Bank.



Step 4: At the ICICI Bank login page, enter your Login ID and Password after clicking on the Login button.




Step 5: On the Dashboard, click on the “Payments & Transfers” tab, and from the drop-down list, select the option “Tax Returns.”
